Article III – Objectives

Section 1: The objectives of the Union shall be:

g) <u>To work collaboratively with any other organizations that support labor.</u> To bring the locals of AFT-W into a relationship of mutual assistance and cooperation with each other and with organized labor.

Article IV - Membership

Section 5: Dues for Members shall be assessed as defined in the By-laws of the Union. Dues are to be obtained through payroll deductions, whenever possible. Dues not obtainable through payroll deduction shall be collected in the manner and form prescribed by the Executive Council. Dues shall increase automatically in an amount equal to any increase in per-capita payments required by <u>our affiliates</u> the AFL-CIO, AFT-W, and AFT at the time such increases occur.

Article V - Officers

Section 2: The duties of the President shall be as follows:

f) Maintain communication with <u>all affiliates</u> AFT-W staff representatives, AFT-W officers, the AFT-W Executive Board and AFT.

Section 5: The duties of the Membership Secretary shall be as follows:

c) Assist the Treasurer in preparing a monthly per-capita membership report to AFT-W and AFT.

Section 6: The duties of the Treasurer shall be as follows:

j) Submit a monthly-per-capita membership report to <u>our affiliates</u> AFT-W and AFT, in the manner and form required by <u>the affiliates</u> AFT-W and AFT, and make timely payment of all per-capita affiliation fees due to <u>all affiliates</u> national and state affiliates of WPEC and the South Central Federation of Labor, AFL-CIO.

Article VIII - The Executive Council

Section 2: The Executive Council shall consist of the following:

d) Any Regular Member not named above who represents WPEC on the Executive Board of AFT-W or AFT, who shall serve in an ex-officio capacity without voting rights.

Article IX – The Convention

Section 4: Delegates to the AFT-W Convention shall be elected by the Regular Members at the WPEC Convention in the number allocated by the AFT-W Convention. Nominations for WPEC delegates to the AFT-W Convention shall be made at the WPEC Convention.

Delegates to the AFT Convention shall be elected in even numbered years by the Regular Members present at the WPEC Convention in the number allocated by the AFT Constitution. Nominations for WPEC delegates to the AFT Convention shall be made at the WPEC Convention.

Article XV – Miscellaneous Provisions

Section 1: The WPEC Constitution shall comply with <u>all affiliate</u> the AFT-W and AFT Constitutions and with State and Federal law.
