## President's Report – 8:55, Greg Georg Reporting

- OSER and the Furloughs will be discussed later in the meeting.
- DOR require criminal background check every 5 years. Last fall DOJ system check was used. 28 WPEC employees have access to lottery information, required finger printing, credit score checking, etc, at the last minute. Third step grievance filed.
- Gang 18 June 8, 2009. Budget was discussed at meeting. Marty (WSEU) information talking with OSER on classification & bargaining dates, contracting out, health insurance amount should be out soon, estimated retirement contributions are out, furloughs will not effect retirement
- Unit clarification article was "leaked" information release. Letter sent to about 2000 WPEC and about 1000 WSP effected UW employees. AFT funding \$40,000 to hire help on project.

## Membership Report - 9:25, Ed Berry Reporting

- All districts membership numbers are down with MOM's being up, except for District 5, which is just the opposite.
- Some Milwaukee County employees will now be paid as state employees at DHS within the WPEC bargaining unit.
- Berry got membership suite information while at PEC. Perhaps we could be on the system as early as this fall. Berry will ask state for new DB fields to use for identifiers.
- OSER is working on unique employer identifier.

- Financial institution changes on CDs need to be reviewed.
- August 7, 2009, fiscal audit will start. Greg and Maggie will review Hudson before then.

### WPEC Elections – 13:37, Greg Georg Reporting

- AFT Dan McNeil says AFT requires election of officers and delegates by membership vote. Our constitution is not in compliance.
- WPEC could be a Council with Districts being locals, but possible need to be okayed by AFT and AFT-Wisconsin.
- Greg wants input/questions from council for McNeil. EC and Elections and Constitution Committees need to get involved.
- Call for Ad Hoc Committee on Election Change.
  - o Motion by Litwin, second by Hynum. Motion carried.

#### Furlough Issues – 14:11, Jill Hynum Reporting

- AFT-W locals and OSER met at AFT-W office (Jennifer Donnelly, Jim Pankratz and a few others). Seems that OSER want locals to sign a side agreement on temporary layoff language.
- Concerns
  - Need to make decisions to sign off on side, open agreement, or do nothing at this time.
  - o Ratification process may be required or legal battle may ensue.
  - o Ratification minimum of 4 weeks, and probably a "no" vote and in fighting.
  - o Could say we have a contract, or work with OSER, or go to membership.
  - FLSA exempt issue, a week at a time for any reduced hours or for the whole furlough period.

- Discussed suggested item on constitutional amendments on creating a solidarity fund committee and on Council VP nominations
