The Joint Finance Committee (JFC) Co-Chairs Rep. Born (R-Beaver Dam) and Sen. Marklein (R-Spring Green) announced the final schedule for four public budget hearings on the budget in April. It is unfortunate that the JFC leadership scheduled **only one virtual hearing**, severely limiting the opportunity for Wisconsinites to participate in these Budget hearings. The JFC Co-Chairs also scheduled the remaining three public hearings in areas not accessible to the largest portions of our state's population to be able to travel and attend Budget hearing in the middle of a workday to testify about the State's Biennial Budget, which has deep impacts on our lives and futures.
